Mayor Bickers called the meeting to order at 6:03 PM.

Mayor Bickers led the invocation and the Pledge of Allegiance to the flag.

MOTION by Gormley to approve the minutes of the May 11, 2021, meeting of the BMA. Second by Kelley. VOTE: UNANIMOUS. **MOTION PASSES.**

Mayor's Report and Approval of Monthly Financial Report:

Financial report for month ending May 31 was reviewed.

MOTION by Gormley to accept the May monthly financial report. Second by Kelley. VOTE: UNANIMOUS. **MOTION PASSES.**

Mayor Bickers communicated that ticket sales are moving along and picking up for the Wolfstock Music Festival set for 2021 August 06 & 07. The Mayor will be exploring options for continued marketing and promotion for this event. Two of the originally scheduled performers have cancelled due to other commitments. New performers booked as replacements include Priscilla Block for Friday and Parmalee for Saturday.

Mayor Bickers announced that a study group will be formed to develop a strategy and details for improvements to Town Hall property. Items envisioned include restrooms , playground, pavilion, ampitheater, food truck court, farmer's market and other enhancements. This group will move forward with a Landscape Architect to develop plans and recommendations.

Citizens Comments: Earl Morgan commented on the lawsuit filed against TVA and the TOL regarding and injury at Poland Creek.

Ordinance 2021-01 passes.

AN ORDINANCE OF THE BOARD OF MAYOR AND ALDERMEN OF THE TOWN OF LOUISVILLE, TENNESSEE, ADOPTING AN AMENDED BUDGET FOR FISCAL YEAR ENDING IN JUNE 30, 2021 (First Reading)

Mayor Bickers reviewed the proposed amended budget for the fiscal year ending June 30, 2021.

MOTION by Gormley to approve the ordinance as proposed. Second by Kelley.

VOTE: UNANIMOUS. MOTION PASSES

Ordinance passes first reading.

AN ORDINANCE OF THE BOARD OF MAYOR AND ALDERMEN OF THE TOWN OF LOUISVILLE, TENNESSEE, PROVIDING FOR THE REGULATION OF THE CONSUMPTION AND SALE OF ALCOHOLIC BEVERAGES IN THE TOWN OF LOUISVILLE (Second Reading)

Mayor Bickers reviewed the proposed ordinance and provided background information which was discussed in detail at the first reading.

MOTION by Gormley to approve the ordinance as proposed. Second by Kelley.

VOTE: UNANIMOUS. MOTION PASSES

Ordinance 2021-02 passes.

AN RESOLUTION OF THE BOARD OF MAYOR AND ALDERMEN OF THE TOWN OF LOUISVILLE, TENNESSEE, AUTHORIZING THE SALE AND CONSUMPTION OF LIQUOR BY THE DRINK AT THE WOLFSTOCK MUSIC FESTIVAL ON AUGUST 6TH AND 7TH OF 2021(Final Reading)

Mayor Bickers reviewed the proposed resolution and provided details regarding the requirement for a Resolution for this event according to Tennessee statutes. After discussion, the BMA agreed to change the second WHEREAS to read “The Town of Louisville’s Consumption of Alcoholic Beverages Ordinance provides for the sale and consumption of alcoholic beverages”. Also, the BMA agreed to insert into the third WHEREAS “;all alcoholic beverages will be sold in prepackaged single-serve cans;”

MOTION by Bickers to approve the resolution as amended. Second by Kelley.
VOTE: 4-1. (Mayor Bickers, Vice Mayor Kelley, Alderman Gormley and Alderman Holley voted YES, Alderman Pugh voted NO), **MOTION PASSES**

Resolution 2021-02 passes.

Other Action Items:

1. **2021 Road Bid Approval:** Town Engineer Swicegood reviewed the bids submitted June 04, 2021 by Harrison Inc., PRI of ET and Duracap. Patty Construction and Rogers Group did not submit bids. The bid by Harrison Inc. was significantly lower than the other two bids and Town Engineer Swicegood recommended the contract be awarded to Harrison Inc.

MOTION by Bickers to approve awarding the 2021 Road Improvement contract to Harrison Inc. as proposed. Second by Kelley. VOTE: UNANIMOUS. **MOTION PASSES**

Harrison Inc. will be notified June 09, 2021 that they are the successful bidder. Town Engineer Swicegood will begin work with Harrison Inc. to develop a schedule for the paving.

MOTION by Gormley to adjourn the meeting; Second by Kelley, VOTE: UNANIMOUS.
