Mayor Bickers called the meeting to order at 6:02 PM.

Mayor Bickers led the invocation and the Pledge of Allegiance to the flag.

**MOTION** by Gormley to approve the minutes of the July 12, 2022, meeting of the BMA. Second by Holley. VOTE: UNANIMOUS. **MOTION PASSES.**

**Mayor's Report and Approval of Monthly Financial Report:**

Financial report for month ending July 31 was reviewed.

**MOTION** by Kelley to accept the July monthly financial report. Second by Gormley. VOTE: UNANIMOUS. **MOTION PASSES.**

Mayor Bickers communicated that the 2022 paving projects will begin this week.

Mayor Bickers reported the legal action taken by the Reeds against the Town officials, the BZA and Bill Mattison. Mayor Bickers explained the allegations against the parties due to the granting of a variance by the BZA.

**Citizens Comments:** John Loope noted that Nathan Thomas volunteered to mow the grass at the Louisville Post Office due to problems the post office has had securing labor. Patrick Porter reported several problems with squatters on Snapp Road surrounding the cemetery. Mr. Porter requested that the Town investigate the situation to determine if there are code violations.

**Resolutions and Ordinances:**

AN ORDINANCE OF THE BOARD OF MAYOR AND ALDERMEN OF THE TOWN OF LOUISVILLE, TENNESSEE, AMENDING A BUDGET FOR FISCAL YEAR ENDING JUNE 30, 2022 (Second Reading)BMA

Mayor Bickers explained the background and reasons for submitting the amended budget for the previous budget year to reflect the final numbers.

**MOTION** by Bickers to approve the ordinance as proposed. Second by Gormley.  
**VOTE: UNANIMOUS. MOTION PASSES**

**Other Action Items:**

1. Review of plans and drawings for proposed playground and pavilion: Representatives of Playworld and T Square Engineering presented current drawings and associated information for both the playground and the pavilion area. Mayor Bickers noted that playground is ready for review by the Design Review Commission and requested approval by the BMA to proceed with this action. The Mayor and Aldermen voted unanimously (4-0) to submit the playground design to the DRC for approval.
2. Appointment to Design Review Board: Mayor Bickers nominated Scott Bassitt to fill the open position on the DRC for the term expiring in 2025.

**MOTION** by Bickers to approve nomination of Scott Bassitt to the DRC for term expiring in 2025. Second by Holley. **VOTE: UNANIMOUS. MOTION PASSES**

3. Update on 2022 Paving Project: Town Engineer Swicegood updated the BMA on the status of the 2022 paving projects. Pride Road was prepped on Monday, August 08 to prepare for asphalt overlay on Thursday, August 11. In the event of rain, the asphalt overlay will be moved to Friday, August 12. All Pride Road and Attley Drive residents have been notified that Pride Road will be closed to traffic except for emergency vehicles from 8 AM to 4 PM during the paving process. Miser Station Road has been marked for grinding and paving limits. This work will probably be scheduled for the week of August 22 but that still has to be determined by the contractor PRI.

**MOTION** by Gormley to adjourn the meeting; Second by Kelley, **VOTE: UNANIMOUS.**
