Vice Mayor Pugh called the meeting to order at 6:02 PM after the Public Hearing for the proposed rezoning at 2965 Samples Road. There were no comments from citizens at the Public Hearing.

Vice Mayor Pugh led the invocation and the Pledge of Allegiance to the flag.

MOTION by Gormley to approve the minutes of the June 14, 2022, meeting of the BMA. Second by Holley. VOTE: UNANIMOUS. **MOTION PASSES.**

Mayor's Report and Approval of Monthly Financial Report:

Financial report for month ending June 30 was reviewed.

MOTION by Holley to accept the June monthly financial report. Second by Kelley. VOTE: UNANIMOUS. **MOTION PASSES.**

Vice Mayor Pugh noted that Mayor Bickers stepfather has passed away and Mayor Bickers will out of town for an extended period.

Vice Mayor Pugh communicated that Playworld has submitted their quotation for the playground. The detailed quotation and scope of supply are being reviewed by T Square Engineering for incorporation into the overall Phase 1 design.

Vice Mayor Pugh announced that the 2022 paving projects should start during the first or second week of August. Town Engineer Swicegood will meet with PRI the week of July 18 to layout final details for the paving.

Citizens Comments: John Loope ask the BMA to reconsider locating the proposed playground to the front side of Town Hall due to safety concerns with the current location. Kerry Finley expressed his opposition to the concept of an event center as part of Phase 1. Numerous others who had not signed the comment list spoke on a variety of subjects.
